- (c) Abandonment: Failure of tenant to occupy the property for the purposes permitted under this lease agreement for ten (1) days, or more, unless such failure is excused under other provisions of this lease agreement.

REMEDIES ON DEFAULT: Termination: In the event of default the lease agreement may be terminated at the option of the lessor, by notice in writing to the lessee. If the lease agreement is not terminated by election of the lessor, or otherwise, lessor shall be entitled to recover damages from lessee for the default. If the lease agreement is terminated, lessee's liability to lessor for damages shall survive such termination, and lessor may re-enter, take possession of the premises, and remove any persons
